Verification. The Subcontractor agrees that it shall complete and maintain Forms I-9, Employment Eligibility Verification, for its employees and shall not knowingly employ or continue to employ individuals who do not have U.S. work authorization. The Subcontractor agrees that it shall extend this requirement to any sub-subcontractor it may engage.

General Conditions of the Subcontract - Workman Commercial

Subcontractor shall notify Tarlton immediately following any accident involving personal injury, property, equipment or material damage, or near miss (i.e. an incident which could have caused either). Within 48 hours, Subcontractor shall provide a detailed written report of said incident.
