What is competency and CLIA competency assessment? Competency is the ability of personnel to apply their skill, knowledge, and experience to perform their laboratory duties correctly. Competency assessment is used to ensure that the laboratory personnel are fulfilling their duties as required by federal regulation.

### What Do I Need to Do to Assess Personnel Competency?

Quest for Quality. The Centers for Medicare and Medicaid Services (CMS) have recently increased their emphasis on Competency Assessment because studies have shown that additional education/training of laboratory personnel produces higher quality laboratory results, and laboratory errors with potential patient impact are often caused by lack of competent personnel. 1

### Competency Guidelines for Laboratory Professionals | CDC

A: Competency assessment is not required for the Lab Director. The Lab Director responsibilities will be evaluated in detail at the time of survey. If the Clinical Consultant and the Lab Director are the same person, competency assessment is not required.

Used by over 1500 laboratories and 200 MT/MLT training programs, MTS's Lab Training and Competency Assessment system provides a comprehensive on-line resource for building competency, improving the quality of laboratory services, and meeting regulatory requirements.

### Clinical Lab - medtraining.org

The CAP provides a competency assessment template for accredited laboratories to assist in documenting testing personnel competency assessments, a version of which can be customized to fit a specific lab's needs. 5 Laboratories also may choose to only keep the completed template in the employee folder and documented evidence supporting the competency in separate location. This is acceptable as long as the supporting documentation can easily be provided if requested by an inspector.
